Collaborating with the communications team to provide advice and support as requested in regards to campaigning (social media) utilizing digital technologies;

Collaborating with the finance team, to provide advice and support as requested in relation to the digital program's administrative and finance affairs;

Securing resources that will support the programmatic work in this area;
